

THIS Trust Deed is made on the 21st day of May, 2002 between Rashmi Johar aged about 34 years d/o Shri Mahender Pal Singh r/o Punjabi Colony, Rajgarh, Lakhimpur Kheri (U.P.) hereinafter called the Founder of the one part and Shri Ramanjit Singh Johar aged about 39 years s/o Late Shri Jaspal Singh r/o Punjabi Colony, Rajgarh, Lakhimpur Kheri (UP), hereinafter called the Trustees of the other part.

Whereas the founder is desirous of founding a School/College in the city of Lakhimpur Kheri for the education of boys and girls in the educative and vocational persuits and for that purpose the Founder hereby contributes Rs. 10,000 into the Trust Fund. The founder will also arrange suitable land etc. on long term lease basis, on suitable terms and conditions for the purpose of construction of school as may be necessary.

And whereas the Trustees have agreed to carry out the Trust herein created.

NOW IT IS HEREBY AGREED AS FOLLOWS:

- 1. The Name of the Trust will be: GURUKIRPA CHARITABLE TRUST.
- The objects of the Trust are
 - a. To open, run and continue a school/college for the education of boys and girls in arts, science, commerce and vocational persuits and to develop character of students as well as to educate them in
 - b. To establish and to maintain a boarding house for the students who receive education in the
 - To establish any technical/ medical/ dental college for the benefit of the students in particular And society in general.
- Declaration of the Trust-

The Founder as absolute owner has delivered cash amounting to Rs. 10,000 and promised to arrange the land for the purpose of the trust on long term lease basis to the Trustees to hold the same unto and to the use of He Trustees upon trust with, under the subject to the powers and provisions herein contained. Powers and duties of the Trustees

The Trustee will do all the needful to establish the infrastructure of the school/college etc. The Trustees shall employ such staff as they think necessary for giving the necessary education and services to the students and replace them whenever they think necessary. The Trustees shall also employ and remove other servants which they consider necessary for the purpose.

Out of the meone of the Trust rand which will also include aids, grants, document ete received by the Trust, the Trustees shall defray the expenses for the running of the school and boarding house and other activities as aforesaid and expenses for erecting building and creating other infrastructure for the purpose the Trustees may use such portion of the corpus of the Trust Fund as may be necessary.

d. The Trustees shall have the power to borrow money from any bank, institution, individual or concern or otherwise on the security of the Trust property and to mortgage/ hypothecate the Trust property for the necessary purpose.

e. The Trustee may invest the surplus funds in their hands in various movable and immovable properties and securities as they deem fit for the objects of the Trust.

5 The Founder shall also be one of the Trustees during her life time and after her death the eldest male Member of her family shall be a co-trustee

The new Trustees can be inducted in the team of existing trustees by the founder as she deems necessary.

If any of the Trustees becomes bankrupt or found guilty by court of an offence involving moral turpitude or become insolvent or remain absent from India for a period of three months or resign from his post or otherwise incapacitated physically, the remaining Trustees with the consent of the founder so long as she is alive shall appoint his substitute.

That the Trustee may accept any gift, donations, aids, grants etc. from individual, concern, body or government.

In case there is a difference of opinion between the Trustees, the decision of the majority of the Trustees relating to the Trust shall be binding and be effectual and shall be carried out.

In case of failure of the Trust for want of its objectives or Trust having been impossible of performance, the Trustee shall move the court for applying the remaining Trust fund for similar project.

The Trustee shall in no case be liable for any loss to the trust estate unless the trustees are found guilty of fraud

This is a public charitable Trust. The properties of the Trust shall in no case revert to the founder or her descendants or to any other person.

The Trustees are permitted to open and maintain in the name of the Trust a savings/current a/c with any schedule bank, which shall be operated by the two Trustees jointly.

That the Trustee shall have the power to refer any dispute to arbitration, and to file suits on behalf of the Trust and to compromise or compound all actions, suits and other proceedings and all differences and disputes touching the Trust properties and to adjust and settle all accounts relating to the Trust and/or its properties.

- That the Trustees shall maintain proper books of accounts for the Trust and shall draw it's Final Accounts 15 on 31st March each year and will also get them audited by a qualified Chartered accountant.
- That the Trustee may reimburse to themselves and pay and discharge out of the Trust fund all expenses incurred in or incidental to the execution of the objects and purposes of the Trust. If they act in any additional capacity in the day to day affairs of the school/college, they may be paid reasonable remuneration for their additional services. 17
- Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.
- The Trustees may from time to time frame rules for the conduct and regulations of the meetings of the Trustees for the operations of the Trust. In the absence of such regulations:
 - a. Two Trustees shall form a quorum for a meeting of the Trustee.
 - b. The meeting of the Trustees shall take place at least once in every calendar quarter.
 - c. Any revision, alteration and addition to the existing rules may be done in a meeting of the Trustees by passing it with a simple majority.
- No part of the Trust fund, either the corpus or the income there from, shall be utilized for any object other 19 than that of the Trust hereby created. 20
- The office of the Trust shall situate at Lakhimpur Kheri (UP) unless otherwise so determined by the 21
- For the purpose of the assessing the stamp duty the value of the Trust property is Rs 10,000 as contributed
